



Trading Chambers uses stringent process for shortlisting Projects. We receive over 500 Applications for funding, initial screening is done on the basis of our minimum qualification criteria questionnaire, Project viability and quality of Whitepaper. 100 of the shortlisted projects are invited to a face to face assessment via organized events. At least 50 are selected for Company visits and further screening happens at Company's premise. We visit them to understand Project and the ICO structure in detail, 20 of the 50 Projects are shortlisted for funding. We invest in them aggressively, participate in their ICOs planning, arrange for more funding if needed and drive the process to closure

Trading Chamber advises various Companies for planning and implementation of ICOs. This process involves non-technical assessment of Business and formulating an ICO strategy.






### **INVESTMENT TRENDS IN ICOS'**
